Property Transfer Fees

Property transfer fees are associated with all QLLA real estate transactions when a title or property is transferred between individuals or entities. The terms of the property transfer are agreed upon by the buyer and seller prior to closing.

Food Minimums

Each member household has an annual **\$500 food minimum**.

Members with Surname beginning **A-K**: *April 1 through March 31* Members with Surname beginning **L-Z**: *October 1 through September 30*
